TERMS OF BUSINESS

DISCOUNTS: A discount of £50 will be deducted if a deposit of 50% of the total estimate or 100% of the third party cost (whichever is greater), is paid before the funeral takes place. (This would need to be cleared funds, in our bank account). The deposit may be paid by bank transfer or debit/credit card (we only accept Visa and MasterCard) by calling 01608 685274 between 9:00am & 5:00pm Monday-Friday. A further discount of £50 will be available if the final invoice is settled within 14 days of the date of issue, which is usually within seven days of the funeral taking place. Please inform us if you intend to pass the account to a solicitor or bank for payment.

REDUCED SERVICES FUNERALS: All reduced service funerals, such as unattended funerals, must be paid in full three working days before the funeral service takes place.

OUR CHARGES: R. Locke & Son Ltd operates a pricing policy in compliance with the Competition and Markets Authority and the Code of Practice of the National Society of Allied and Independent Funeral Directors. Our additional options price list provides clients with a full and detailed explanation of our charges as required by the Code.

THIRD PARTY COSTS: In addition to our charges, we will, on your behalf, pay the third party costs to the other parties involved with the funeral and these will be added to your account.

ESTIMATE: When the funeral arrangement plans are completed you will be given a written estimate of all the charges incurred by the service you have requested. We ask for this estimate to be signed as consent that you accept the charges and will be liable for payment of the account.

INTEREST: We reserve the right to add interest on all outstanding accounts at 2% per month on accounts that remain unpaid after 60 days and, in addition, any legal, debt recovery and court costs incurred due to non-payment. Un-paid accounts will be passed to our debt collectors for recovery of the debt.
